1. *This deposit is not refundable if purchaser changes his/her mind regarding the puppy. If there are insufficient puppies in the litter to satisfy the demand;
 - a) I will refund your deposit or;
 - b) Move you up the waiting list if so desired

2. The breeder's decision is final as to the puppy you receive, but we will make every effort to provide you with the puppy you want.

3. A female puppy is purchased with the understanding that she will be spayed within the first year of birth unless she is co-owned by the breeder. The only exception will be if there is a written understanding with breeder and purchaser before possession of the puppy is taken. Unless there is a written understanding between breeder and purchaser, if the female is not spayed within the first year, then said puppy will be returned to breeder with no refund to purchaser. Purchaser will provide copy of the spay certificate to breeder.

4. A male puppy is purchased with the understanding that he will be neutered within the first year of birth unless there is a prior written agreement that the dog might be shown. In the event that the dog is shown and it is eventually proven that he is not show quality, he must be neutered. All male pups will be registered under a limited registration. If breeder decides that the male pup must be neutered, he is to be neutered within one year of this decision or said dog will be returned to breeder with no refund to purchaser. Purchaser will provide a copy of the dog's neutered certificate to Breeder.

5. The yard of the purchaser must be fenced before taking possession of the puppy unless prior understanding exists between purchaser and breeder regarding a fence to be built. Breeder requests that this puppy be micro-chipped and breeder provided with such number.

6. All show potential puppies will be evaluated around 12-15 months of age. If deemed show quality in the breeder's sole opinion, the limited registration will be changed to a full registration at purchaser's expense. The breeder reserves the right to co-own the puppy if this condition exists.

ARBITRATION CLAUSE

Any dispute arising between the parties to this Agreement or involving the interpretation of this Agreement or any breach thereof shall be submitted to and determined by arbitration in the State of Pennsylvania before the American Arbitration Association and in accordance with the rules then obtaining of said Association and the laws of the State of Pennsylvania.
